At a minimum we had addicts from all across the Northshore, New Orleans, and even MS. The cost of the event was \$350 for the rent of the building. Most home groups donated food or monetary donations. The cash/app donations from home groups were \$195. 7th Tradition was \$91. Food Donation Box was \$35. Live auction income was \$395. Silent Auction income was \$370. 50/50 proceeds were \$190 to us. This brings our total money collected to \$1,276. Less our \$350 rent expense, our total profit is \$926. The total area will receive is \$1676 which includes the \$400 in seed money for food & other expenses which was not used. I do not have the money with me today.
